When performance criteria aren't met, you receive an email notification. Operators are automatically expired and you define the expiry date. Once the operator passes the e-learning again, he is automatically re-certified. Operators are regularly assessed and retrained.

Optimize device uptime and sample flow data

Save time in searching for issues – with the AQUIRE IT solution, you can immediately receive an email notification regarding urgent actions.

The AQUIRE IT solution helps you troubleshoot issues through a guided process. When the issue has been solved, you can document root causes and corrective actions so you have complete documentation with full traceability for regulatory compliance.

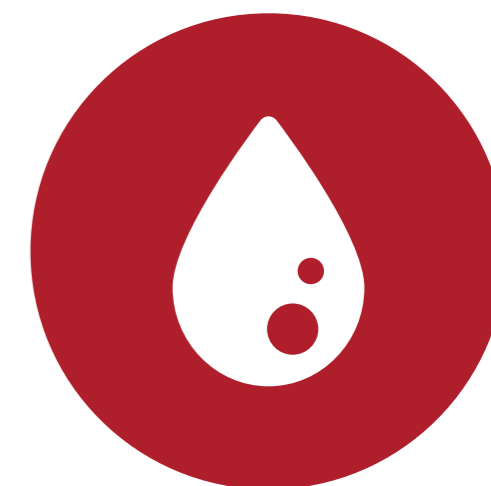

A PROACTIVE APPROACH TO CONTROL ANALYZER QUALITY AND PREVENT POTENTIAL ISSUES

With AQUIRE Peer Quality Control, you can validate your analyzers' performance on a daily basis by measuring your analyzers' QC performance against analyzers in a peer group. The performance can be automatically documented in a monthly report.

You can access peer data from four different peer groups when troubleshooting QC violations to identify systematic or local trends on QC data. On a daily basis, you can distinguish statistical deviations and explore them in a Levey-Jennings plot before they become a violation. Monthly, you can get ready for inspections with Peer Quality Control reports.

You have a Master Patient Index for Positive Patient Identification. After scanning the patient barcode, patient information is shown on the screen for you to confirm the patient's identity.

You can also set up rules to define your validation requirements prior to sending results to LIS/HIS. Set the demographic

query for Positive Patient Identification and get improved patient data workflow to support patient care.
